
present in a few sectors to a truly global powerhouse present across the entire infrastructure value chain.

#### Asia's longest double-decker viaduct inaugurated

Asia's longest 5.3km doubledecker viaduct, part of the Nagpur Metro Reach-2, was inaugurated on October 5, 2024, by Shri Nitin Gadkari,



the Honourable Union Minister for Road Transport and Highways, Govt of India. This double-decker viaduct also passes through India's first four-level transportation corridor. Both these engineering marvels, constructed by Afcons, has significantly reduced the travel time between Kamptee and the airport.

#### PM inaugurates Ahmedabad Metro Phase-2

Honourable Prime Minister of India Shri Narendra Modi inaugurated 20.8km section of Ahmedabad Metro Phase-2 on September 16, 2024. The metro was flagged off from Gandhinagar Sector-1 station. Afcons has completed the viaduct portion from Motera Stadium (main line) to the GIFT City spur line along with three stations at GIFT City, PDPU, and GNLU.

#### **EAM** visits Greater Male **Connectivity Project**
